i) <u>Cash Dividends</u>

The declaration of \$\mathbb{P}\$0.042 per share cash dividend to all shareholders of record as of 5 March 2012, to be taken from the unrestricted retained earnings as reflected in the audited financial statements of the Issuer as of 31 December 2011, to be paid on or before 16 March 2012.

ii) Loan Guarantee of FBSHI Loan

Passed resolutions to authorize the Issuer to guarantee in part, to the maximum extent of 50%, the term loan of its affiliate, Fort Bonifacio Shangri-La Hotel, Inc. (FBSHI) from Banco de Oro to partially finance the construction of a mixed hotel and residential/service apartments at the Bonifacio Global City in Taguig City.
